1. PURPOSE

This Privacy Policy has been created in order to inform you of the information collection, use, disclosure and secure management of your personal information by Do Dance Academy. Do Dance Academy are bound by the Australian Privacy Principles (APPs) contained in the Privacy Act 1988.

In summary 'personal information' is information or an opinion relating to an individual which can be used to identify that individual.

2. COLLECTION OF PERSONAL INFORMATION
